1. BACKGROUND

VinUniversity (VinUni) is implementing its research strategy to achieve QS Top 100 standards by 2030 through global research networks and high-impact research. To achieve these goals, VinUni has outlined a roadmap to establish five RISE Hubs, each focused on a distinct research domain: Health Sciences and Smart Care; Environment Intelligence; Robotics, and Artificial Intelligence; Intelligent Computing and Data System; and Policy Research and Sustainable Urban Development.

Operating under RISE hubs are Research Centers, aligning with their thematic priorities to drive interdisciplinary innovation, optimize impact and contribute to Top 100 QS World University Rankings Goal. These Centers manage independent budgets, staffing plans, and KPIs, organizing research groups with VinUni faculty, external researchers, postdocs, and graduate students.

2. PURPOSE

This policy outlines the formal evaluation process for establishing new research centers at VinUni. The process ensures that all proposed research centers align with the university's strategic objectives, impact, innovation, industry engagement, international engagement, as well as contribution to ranking goal and financial sustainability.

3. SCOPE

This policy applies to all proposals for new research centers submitted to VinUni, involving faculty, staff, and external stakeholders as applicable.

4. EVALUATION PROCESS

The establishment of new research centers at VinUni follows a structured three-tier evaluation process, designed to rigorously assess strategic alignment, scientific focus and financial feasibility. The process is summarized in the table below.

Guiding Notes:

- **Submission Guidelines:** Proposals must be submitted in accordance with VinUni templates (Annex 1), submission guidelines and deadlines.
- **Committee membership:** Committees may include interim academic members to support the review process as needed.
- Conflict of Interest: To maintain impartiality, members of the VinUni evaluation committee who are proposers or have a direct interest in a proposed research center (e.g., Vice Provost for Research and Innovation or College Deans proposing their own research center) must recuse themselves from the evaluation process for that proposal. In such cases, the committee will appoint alternate members or rotate membership to avoid conflicts of interest and ensure unbiased review.
- **Documentation:** All decisions are documented and communicated to proposers in a timely manner.
- Ethics Integrity: Research activities are expected to be performed with honesty and integrity, to meet the highest ethical standards, and to respect the contributions and scholarship of others.

5. EVALUATION RUBRIC

A standardized evaluation rubric is used to assess proposals at each stage. The rubric includes criteria such as Strategic Fit, Interdisciplinarity and Leveraging Potential; Scientific Excellence contributed to QS 100 Goal; Impact & Innovation; Industry and International Engagement; and Academic Leadership and Research Capacity. Detailed guidelines and scoring criteria are provided in Annex 2 "Guideline of Research Center Evaluation Rubric".
